Summary of the CIDQ Annual Meeting of Delegates in Atlanta, 2015

The CIDQ has a new Executive Director, Thomas ("Thom") Banks, who was with ASID. While not announced at the meeting itself, it was announced some weeks later, on December 7, 2015.

CIDQ (Council for Interior Design Qualification), the governing body of the interior design licensing exam, the NCIDQ, met in Atlanta on November 12th through 14th.

Almost every state (not all states have member boards) and Canadian provinces were represented.

Organizations who participated included:

ASID, IIDA, IDCEC, IDC (Canada)

Other attendees were design stakeholders: Health Design professionals, educators, state administrators, students

Discussions and updates touched on the following issues:

- Rolling out the computer-based NCIDQ exam. The CIDQ wants the entire exam to become
 computer-based, which means that the Practicum section has to be brought into the computer
 world. The goal is to have the Practicum as a computer-based exam by 2017);
- Newly graduated students can take the first part of the NCIDQ exam immediately after graduation, once they've qualified to sit for it;
- Discussions from CIDA ("seeda") Council for Interior Design Accreditation
 - One issue of some concern is that there is a growing number of institutions that are asking for CIDA accreditation and therefore there are more institutions which need regular reviews;
 - There was some discussion of CIDA-equivalency regulations and ways to allow graduates of non-CIDA accredited programs to sit for the NCIDQ exam (for example, having a peer review committee);
- Talk of legislative issues by state;
 - These issues revolved around developing further regulation, as there is such a highly varied set of regulations in the US. The regulations range from states which have no regulations at all to those that require licensure and allow interior designers permitting privileges.
- Discussion of the "Champions and Ambassadors" program to encourage designers and educators to sit for the NCIDQ exam
