RE: # OOG-2025-0051 Dismissal of Complaint (Out-of-State Board)

Dear

This correspondence concerns the complaint you submitted to the Board of Ethics and Government Accountability, Office of Open Government (OOG) on February 27, 2025. Your complaint alleges that you want the Montcalm County Board of Commissioners in Montcalm County, MI, "investigated" because you "believe they hide concerns that directly can impact the constituents" and you "want to publicly discuss my concerns so area officials and community members can understand what is going on."

Presumably you have reached out to OOG because you wonder whether the Montcalm County Board violated the Open Meetings Act (OMA) (D.C. Official Code § 2-571 et seq.). The Director of Open Government has no statutory authority to resolve the allegations you raise in your complaint because public bodies not subject to the OMA, which includes any public body not constituted in the District of Columbia, are excluded from the OMA. Therefore, your complaint is dismissed for the reasons stated below.

OOG's legal staff reviewed your complaint, assigned file number OOG-2025-0051, pursuant to 3 DCMR § 10400 et seq., and recommended dismissal due to the threshold question of whether the Director of Open Government has jurisdiction over the public body referenced in the complaint. The enforcement authority of the OOG extends only to violations committed by District of Columbia public bodies under the Open Meetings Act (OMA) (D.C. Official Code § 2-571 et seq.) I do not have authority over any public body not defined by D.C. Official Code § 2-574(3), including any public body in the State of Michigan. I only have statutory jurisdiction over a public body's meetings when that entity is subject to the OMA. 3 DCMR § 10403.1(a) provides that I may dismiss a complaint that "does not raise issues within the Director's authority under the Open Meetings Act." I must dismiss this OMA complaint because it does not raise issues under my authority. I did not consider the merits of your complaint because the threshold question of jurisdiction was not met.

OOG recommends that you contact the Michigan Board of Ethics, as that governmental entity likely has jurisdiction over the matters you raise in your complaint.
