

# Healthy Youth and Schools Commission Meeting June 13, 2024 10:30 a.m. - 12 p.m.

### Welcome and Introductions

- Chairperson Kristy McCarron called the meeting to order at 10:35 a.m.
- Commissioners introduced themselves.

### **Recap of the Previous Commission Meeting**

### **Discussion: Commission Format**

 Chairperson McCarron discussed the format of the commission and the challenges commissioners face due to the current format, and she proposed a commission structure and meeting format where the HYSC will serve as consultative body for community-based organizations (CBOs) and District agencies that impact the health of District youth by providing tangible feedback.

- Chairperson McCarron invited commissioners to provide suggestions and share their thoughts on the usefulness of the proposed structure.
- Caitlin Shauck, Policy Analyst at OSSE, mentioned there is an open seat for a youth commission member and also discussed the purpose and function of the HYSC. For more information, visit:

- Commissioner Mbinack shared an update on a program through which students learn to ride bikes and another program where students obtain their scuba diving certificates in Florida.
- Commissioner Brumsted shared several updates from the Office of the State Superintendent of Education including:
  - The District of Columbia is participating of SUN Bucks, also known as Summer Electronic Benefit Transfer (EBT), which helps families with students buy food during the summer with the goal of closing the summer hunger gap and increase access to nutritious meals.
