#### I. Call to Order

#### **II. Public Comments**

Public Comment by Alicia Rucker, long time resident of Deanwood, testified about the importance of quality out-of-school-time programs and that all children should have access to appropriate and effective programs. Organizations should receive their funding in a more timely manner so that staff can be paid. Furthermore, all organizations should receive funding and not only the neighborhoods designated as troubled.
