5.1 Align Health and Education Systems

OSSE designs and implements systems of support for early childhood programs and schools on how to integrate essential components of the Whole School, Whole Community, Whole Child (WSCC) model.

- Revise Health Ed and Physical Ed State Standards
- Strengthen school health policy & practices
 - Immunizations
 - Undesignated Emergency Medications
 - Cardiac Emergency Response Plan (CERP)
- Ensure student access to summer meals
 - Increase HS student participation in summer DC Youth Meals program
 - Support DHS to administer Summer EBT grocery benefits

5.2 Invest in the Mental Health of Students and Staff

OSSE expands trainings and supports provided to early childhood programs and schools on how to design and implement systems that promote mental health and wellness for students and staff.

- Support school implementation of data-informed student and educator wellness approaches
- Execute signature ARROW workforce retention activities
 - Launch Youth Mental Health Ambassador program in charter high schools
 - Pilot school mental health peer mentor program
 - Learning Cadres
 - Retention bonuses for supervisors
 - Redefine and Implement ARROW workforce recruitment approach

5.3-4 Help Build Inclusive Communities

OSSE expands support offerings to schools on building positive student cultures and inclusive learning environments so that all students feel safe and welcome and part of the community.

- Launch citywide School Climate Survey
- Pride Investments
 - Operationalize OSSE's new policy "equity audit"
 - Equip educators to implement sexual and reproductive health standards and instruction with inclusivity and respect
 - Increase educator social-emotional learning knowledge and skills

5.5 Reduce Chronic Absenteeism

OSSE evaluates, coordinates, and strengthens OSSE's existing data, policy, and school-based supports and identifies aligned, high-impact new investments to help ensure all students are attending school on a regular basis and reduce chronic absenteeism.

- Advance existing efforts
 - Data analysis, reporting, and resource development
 - Develop and disseminate digital Truancy Resource Guide
 - Youth Re-engagement efforts
- New "Big Bets"
 - Hire State Attendance Coordinator
 - Integrate intensive absenteeism reduction supports into OSSE's School Improvement portfolio
 - Establish clear, vertical alignment of SEA > LEA strategy and processes for youth disengagement prevention, reengagement, and re(introduction) to post-secondary opportunity.
