#### **Call to Order**

A meeting of the Vision Zero Major Crash Review Task Force was held at the Citywide Conference Center at 441 4<sup>th</sup> St. NW on Wednesday, November 28, 2018 at approximately 3:00 p.m. Attendees included the persons listed in the attached sign-in sheet. At least four of six voting members were present, which constitutes a quorum.

#### **Approval of Minutes**

Pursuant to D.C. Official Code § 2-575(b)(1), the session can be closed when a “law or court order requires that a particular matter or proceeding not be public.”

During the closed session, the task force discussed several crashes from the year 2017, reviewed draft findings and recommendations, and further outlined the format of the annual report. The task force continues to aim for a near-final report for review by the December 19, 2018 meeting.
