Minutes

Call to Order

A meeting of the Vision Zero Major Crash Review Task Force was held at the District Department of Transportation at 55 M St. SE on Wednesday, February 26, 2020 at approximately 2:30 p.m. Attendees included the persons listed in the attached sign-in sheet. Five of the six voting agencies were present when the meeting was called to order, which constituted a quorum. The sixth voting member arrived after the meeting was called to order.

Open Session

The Task Force discussed the January 29, 2020 meeting minutes from the prior meeting. Linda Bailey motioned to approve the meeting minutes, Eileen McCarthy seconded the motion, and the motion was passed unanimously.

Closed Session

The Task Force agreed to proceed to crash review, and to enter a closed session to do so. Pursuant to D.C. Official Code § 2-575(b)(1), which allows for closure of a meeting or portion of a meeting when a “law or court order requires that a particular matter or proceeding not be public,” the Task Force moved into a closed session because members specifically discussed the details of major crashes, which contained personally identifiable information and other sensitive material. The closed session involved review of review video and photographic records memorializing vehicular, pedestrian and other modal collisions and related fatalities, which may reveal images of such a personal and graphic nature that revelation in an
