 - o The CEU requirement has been eased from a requirement of 6 units to 3 units for this cycle only. Credits may be obtained from any DC approved CEU provider. A list of providers is available; you may check with the Board Administrator to determine if a course qualifies. Virtual and In-person providers are available.
- Caller If I am unable to upload the CEU certificate, how can I complete my license renewal?
 - If you are unable to upload the certificate, hold on to your certificate as there may be a random audit later in the year to provide proof of obtaining the required units.
