Agenda Item - Pre-Need

A status and report of the Pre-Need Audit letter that was mailed and emailed to all Funeral Home Establishments (FHE) was provided to the Board. The Credential Management System currently lists twenty one (21) FHEs with pre-need escrow contracts. Board Administrator Pamela Hall indicated that while we have received more than half responses from the inquiry, FHEs are still submitting the Attestation Forms. The Board will receive the final audit results at the June 1, 2017 scheduled meeting.

New Business

In accordance with § 47-2831.07 (a), Lynn Armstrong-Patterson, Chairperson, Board of Funeral Director, is no longer on the Board of Funeral Directors, effective with this May 4, 2017 meeting. Ms. Armstrong-Patterson, after asking for volunteers, nominated John McGuire to be the new Board of Funeral Directors Chairman, to begin June 1, 2017; and with a majority vote, the nomination passed.

Member Asanti Williams was nominated as Vice-Chairperson, and with a majority vote Ms. Williams selected.
