The public meeting was called to order by Chairman Huff at 12:06 pm and attendance was taken.

• Commissioner Lockett – Since Delano Hunter is no longer the Director of DPR, should the Commission begin discussing a partnership with the acting DPR Director or wait until the council appoints a new Director? The Commission unanimously agreed to wait until a new DPR Director is appointed.

Upon a motion duly made by Commissioner Mitchell, and properly seconded by Commissioner Townsend, the Commission unanimously voted to enter into Executive Session.

Upon a motion duly made by Commissioner Jenkins and properly seconded by Commissioner Lockett, the Commission unanimously voted to approve the Meeting Minutes for February 8th and March 8th of 2023.

Agenda Item: Complaint:

• Mr. Chauncey Flowers file a complaint on behalf of his son Boxer Chamar Flowers regarding the official's TKO ruling at the Davis Promotions Boxing Event on 3/25/2023. Mr. Flowers wants the ruling changed to No Contest or to have the fight deemed as an exhibition on his son's record.

Upon a motion duly made by Commissioner Jenkins and properly seconded by Commissioner Mitchell, the Commission unanimously voted that the official's TKO ruling remains as stands.

The Commission will provide a written response to the complaint.

Agenda Item: Old Business:

- Wrestling Exhibitions Licensing requirements for professional wrestling events that are not stand-alone but are an attraction as part of another event. Chairman Huff recommended the following:
 - ➤ Permit fee of \$100
 - ➤ Licenses and Medicals for all participants
 - > Proof of Insurance

Upon a motion duly made by Commissioner Jenkins, and properly seconded by Commissioner Mitchell, the Commission unanimously voted to approve the policy for wrestling exhibitions that are an attraction as part of another event.

• 5% Commission Fee for Small & Local Promoters of Wrestling & Boxing Events – Chairman Huff reached out to neighboring jurisdictions and those about the same size as DC and found that the District's Commission fee is in line with their fees. Deputy Commissioner Brown talked about the idea of creating a tiered system. Commissioner Jenkins recommended that the Commission consider slightly lowering the fee



or offering tax incentives as a way to be more competitive, especially for smaller and local promoters. Commissioner Lockett suggested having a partnership(s) with a local hotel(s) for room and/or meal discounts to reduce costs for promoters. Chairman Huff mentioned a grant offered by the Office of Cable Television, Film, Music, and Entertainment (OCTFME) for televised or streamed events as another option to reduce costs.

- **Davis Promotions Boxing Event Recap** There was concern regarding the sportsmanship and behavior of some of the licensees at the weigh-in and the event itself. The Commission will be taking action regarding those actions at the next meeting. Will provide Promoter Eric Davis with a letter to provide feedback on the event.
