### **Approval of Minutes**

### **Live. Long. DC. Data Report**

The report of Dr. Orlando Barker, director of the Office of Opioid Abatement, titled “Live. Long. DC: State Opioid Response Funding Report” was received. The full report is available.

Dr. Laverne Adams stated that funding for the faith-based organizations “seems to be so meager for the group of people who are closest to the problem,” and that more funding to these organizations could be beneficial.

Dr. Bennett stated that the Commission could get funds out quicker by expanding initiatives that already being funded by government agencies.

Larry Gourdine recommended that a comprehensive list of MOUD providers, comprehensive list of all recovery housing and their capacity is needed.

Dr. Edwin Chapman suggested that there may be a need for a third party entity to track data

Dr. Bennett stated that there is a lot of local data that exists and that DC Health could immediately use funding to enhance government data evaluation efforts.

Christina Henderson recommended funding the Fire and Emergency Services post-overdose response team.

Dr. Bennett also recommended that funding could be used for purchasing more harm reduction vending machines.

Ciana Creighton stated for the subcommittee it would help if to create a template for reporting out goals and outcomes.

Dr, Bennett stated that each subcommittee will need some time to meet in the next few weeks and will have a data request. Furthermore, if they do meet they will generate ideas.

Patricia Quinn recommended that invites be sent to the entire Commission for the subcommittee meetings.

Jacqueline Bowen suggested that after the first Commission meeting of the year every other subsequent Commission meeting be conducted virtually.
