I. Call to order

Approval of agenda and minutes

II. Official Business

Bernice McIntyre - Discussion on the SEUAB Annual Report

- Ms. McIntyre stated that the Board is required under the law to submit an annual report to the City Council. It was noted that the report is due at the end of November
- Ms. McIntyre and Lynora Hall agreed to arrange a conference call with Board members in order to assign sections of the report to be completed
- The Board needed a copy of the DCSEU Annual Report from last year
- Mr. Trabue stated that most of the information needed for the Board's Annual Report will be presented in the PowerPoint Presentation that day, and a copy would be provide to the Board
- Ms. Mattavous-Frye said previously there was discussion on having the submission date
 for the report changed and asked what happened to the request. Ms. McIntyre stated
 there was discussion and the date change was preferable to the Board. Ms. MattavousFrye asked was the request formally made to City Council. Mr. Anderson answered no.

- Dr. Lawrence stated that the request was made but it was not adopted in the final version of the legislation that was enacted.
- Bernice McIntyre asked for volunteers from the Board members to prepare the report. Joe Andronaco, Chairman Betty Ann Kane, Sandra Mattavous-Frye, and Dr. Donna Cooper volunteered. - Electric Savings (MWh) Benchmark was "Achieved"
- Gas Savings (Mcf) Benchmark is "To Be Determined".
- Low-Income Spend Benchmark was "Achieved"
- Green Jobs Benchmark was "Achieved"
- Largest Energy Users Benchmark was "Achieved"
- Renewables: 10% Annual Cost Reduction Benchmark was "Not Achieved"
- Certified Business Enterprise (CBE) Spend Contract Requirement was "Achieved"
- 80% Electric & 20% Gas "Split" of Spend Contract Requirement was "Achieved"
- Mr. Trabue introduced two new DC SEU staff members, Tanya Wideman and Algernon Jones

 The American Council for an Energy-Efficient Economy (ACEEE) has ranked the District of Columbia 21st in the 2014 State Energy Efficiency Scorecard, moving up nine spots to become one of the most improved states.

V. Marcus Walker – Update on DC SEU FY 2015 Operating Plan & Performance Measurements

- Mr. Walker discussed FY 2015 Focus items:
 - o Higher savings, more green jobs, and smooth out the hockey stick spending pattern
 - Use the work of the DC SEU to create greater impact as it relates to education, housing, transportation, seniors, and public safety
 - o Leverage additional funds: Bid Energy Efficiency into PJM
 - o Improve program delivery, customer experience, operational efficiency, and process flow
 - Mr. Jermaine Brown suggested that the DC SEU look into some new innovative programs and to have a discussion on a Low-Income Solar Farm. Mr. Trabue suggested that they schedule to meet later to discuss.
