5. Comments by Board Members and Members of the Public

Comments were made by Board members.

- "Anthony Dale" creation of a functional document to identify how the CCCB operates and functions and how we move things along that can be distributed not only once the board members, but to members of the public just.
- "Eric J. Jones, MSF aoba" Uh, voting would take place this way, and it, it literally lays out all those things which we're now referring to. And that's what I mean, by the rules of the meeting, it actually delegates the rules for the verse, as opposed to the apprenticeship.
- "Joel Causey" had concerns about being allowed to discuss procedures and individuals in the public speaking completely out of line. Individuals who are not members. If this behavior continues, then he suggests that we mute during the process and only unmute them during the comment period much like other boards do in the city.

Several comments were made by members of the public.

- "Rob Hawkins" Commented on the public Would have to be monitoring, the many tags. There are, which is an incredible burden on their time. And you're asking a lot of them are, you're asking a lot of them to show up once a month and be prepared. To ask their questions and to deliberate to ask them to participate in every 1 of the tag meetings. I think it's incredibly burdensome. I do want to point out though, that in the agenda. You just told me that you're not trying to restrict. It it is explicit you say we must refrain. From questioning the tags findings that's a very problematic statement. It is the duty of the to deliberate and to discuss and to question.
- "Max Brown" submitted questioning of the Technical advisory Groups discussion of proposals and limitation of the Board discussion. Respectfully requested the chairman to reconsider that specific language, and perhaps modify it to make it more inclusive and giving the direct authority to change and deliberate anything that the tag might do.
- "Nick Weil" had some worry about intention among the board about Robert's rules binding you into, or out of a particular means of conducting meetings, and I'm just reminding the board that even under the strictest observance of Robert's rules, even ROBERTS itself and your own bylaws Permit you to depart from Robert's rules or through special rule through unanimous consent.
